In the reference cited, Superintending Engineer/Operation/ Tirupati has submitted an estimate for execution of works under turnkey basis by the consumer for extension of supply to 1No Cat-II Service with CL of 54KW to M/s. Rama Engineering College, Venkatapuram, Karakambadi in Operation, Renigunta and the proposal was sanctioned vide sanction No. WE/NP/No.107/07-08, dt:19.12.07 at an estimated cost of Rs.2,56,925/- (G) & (N). The proposal involves (1) Erection of 480mts 11KV line with 55Sq.mm AAAC over proposed 9.1mts PSCC Poles (2) Erection of 100KVA DTR (3) Erection of 1No. CT Meter (4) Releasing of LT service with 54KW and requested for approval for Turnkey basis.

After careful consideration of the proposal, approval is hereby accorded for execution of the above work under turnkey basis by the consumer except 1 No. 100KVA DTR and the same 1No. 100KVA DTR is to be supplied by the department for which the cost of the DTR shall be collected from the consumer. It is the responsibility of concerned Asst.Divisional Engineer/Operation to ensure the quality of work. The Superintending Engineer/Operation/Tirupati is requested to arrange to collect the supervision charges equivalent to 10% of Gross estimate cost from the consumer before taking up the work duly following all other departmental procedures in vogue.

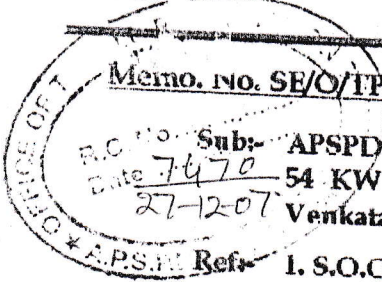

In exercise of powers delegated in S.O.O.(GM-Opn.) Ms. No. 171/Dt. 28.01.03, the Superintending Engineer / Opn. / Tirupati sanctioned the estimate for "E/S to releasing of 1 No. Cat-II service with a C.L. of 54 KW in favour of Sri Mannem Rami Reddy, M/s Rama Engineering College, Venkatapuram, Karakambadi in Opn. Section/Renigunta" and the total Estimate cost works out to Rs. 2,56,925.00 and the expenditure is chargeable to NP funds for the year 2007-08.

The Sanction is registered as WE/NP/No. / 07-08, Dt. 19. -12 - 07.

The Expenditure is debit to the Head APSPDCL Capital received and expenditure B. Expenditure 3.3. Distribution System (including Sub-station) Capital works in progress distribution (Medium and low Voltage) A/c.No. 0206 High Voltage (A/c.No. 0206) Public Lighting equipment (A/c.No. No. 0207).

The Divnl.Engineer / Opn. / TIRUPATI should collect agreement from the agricultural and industrial consumers covered in the working estimate before taken to the works.

The Divnl.Engineer / Opn. / TIRUPATI should maintain separate accounts for the villages executed under composite scheme including expenditure incurred for service connections.

The total expenditure on the works should not exceed the scheme cost in the final year of Opn. of the Schemes.
