### **Agenda - 1: Action taken report on First Academic Council Meeting Minutes**

#### **Resolutions:**

The Principal welcomed all Academic Council Members to the meeting and presented the Action Taken Report on the First Academic Council Meeting Minutes held on August 12, 2024. The members took note of the ATR.

### **Agenda - 2: Recommendations of BOS Members on SRET24 Regulations and Syllabus of B. Tech, M. Tech & MBA**

#### **Resolutions:**

The principal presented the recommendations and proposals provided by the members of the Board of Studies from all departments. After thorough deliberations among the members, the following items were approved.

1. The assessment of Theory and Practical courses for all B. Tech Programs will consist of 30 marks for Internal Evaluation and 70 marks for the End-Examination, in accordance with the Regulations of JNTUA, Ananthapuramu.
2. The attendance requirements shall be followed as per the guidelines given by the JNTUA, Ananthapuramu regulations.
  - i. A student shall be eligible to appear for the external examinations if he/she acquires a minimum of 40% attendance in each course and a minimum of 75% of attendance in aggregate of all the subjects.
  - ii. Condonation of shortage of attendance in aggregate up to 10% (65% and above and below 75%) in each semester may be granted by the Academic Council.
  - iii. Shortage of Attendance below 65% in aggregate shall in NO CASE be condoned.
3. The members of the BOS do not have the authority to modify or alter the academic regulations. They have the permission to provide proposals, which will then be deliberated upon during the Academic Council Meeting. Academic Council will make the final decision.



4. It should be essential to publish the M. Tech project in a conference or journal in order to be awarded the M. Tech degree.

### **Agenda - 3: Approval of SRET24 Academic Regulations**

#### **Resolutions:**

The Principal introduced a draft SRET24 Academic regulations for B. Tech, M. Tech, and MBA, and the members of the Academic Council have given their approval.

### **Agenda - 4: Approval of SRET24 Syllabus for I Year of B. Tech, M. Tech & MBA**

#### **Resolutions:**

The Principal presented the draft SRET24 Syllabus for the first year of B. Tech, M. Tech, and MBA programs, and the members of the Academic Council have given their approval. #### **Resolutions:**

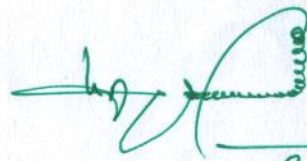
Academic Council Members have accorded permission for implementation of SRET24 regulations and syllabus from the AY 2024-25.
